Healthcare Benefit Trust Appoints New Trustee

Healthcare Benefit Trust (HBT) is pleased to announce that Tom Crump has been appointed to the HBT Board of Trustees as of March 25, 2012 for a three year term. Additionally, Zulie Sachedina has been re-appointed to the HBT Board of Trustees for a further three year term until May 22, 2015.

HBT Board of Trustees

Ed Robinson, Chair

Ed Robinson was appointed Chair of the Board of HBT on February 1, 2009. Ed has 35 years of management and senior leadership experience with 15 of those years in senior executive positions in the Group Life, Health and Pension Benefits industry. He served as a member of the Board of Directors for the Vancouver Island Health Authority from March 2002 until March 2010. During those years he was a member of the Health Quality Committee, Governance Committee and served as Chair of the Finance and Audit Committee from March 2002 until December 2009. He was also appointed to the BC Health Minister's Committee for Financial Management of Health Authorities. Ed was the Senior Group Insurance Executive and President of Aetna Health Management during a ten year career with Aetna Canada. Ed was honoured with the Queen's Golden Jubilee Medal of Distinction in 2003 for his contributions provincially and nationally. Also to his credit, he has held positions on over 19 Boards and Councils, some of which include: BC Buildings Corporation, Community Futures and advisory boards for the NRGH Hospital Foundation and Vancouver Island University. Ed graduated from McMaster University with a Bachelor of Commerce in finance and marketing, has completed advanced studies towards his Master of Business Administration degree, and holds his chartered accountant and certified management accountant designations.

Bill Boomer

Appointed to the HBT Board of Trustees on February 1, 2008, Bill is the Vice-President and Chief Financial Officer of the Vancouver Island Health Authority. Prior to his current role at VIHA, he was the Regional Director, Finance. Bill joined the health sector in 1999 after 19 years in public sector financial administration with the Province of BC. He is Vice-President and Secretary Treasurer of the OBL Continuing Care Society.

Alan Cooke

Alan Cooke was appointed to the HBT Board of Trustees on February 18, 2011. Alan is a retired actuary with 40 years' experience in the benefit, investment and insurance fields. Tom Crump was appointed to the HBT Board of Trustees on March 25, 2012. Tom is currently the General Manager for Bethshan Gardens and recently retired as Administrator for Zion Park Manor. Bob has also served on the boards of Vancouver Community College, the Physical Medicine Research Foundation, the Canadian Life and Health Insurance Association, and BC Children's Hospital Foundation, Planned Giving Committee.
