This Administrative Guideline is to advise you of the new Extended Health plan provision that was recently negotiated under the 2012 - 2014 Community Collective Agreement.

Changes to Extended Health Plan Effective April 1, 2013	
Dispensing Fee Cap	A dispensing fee cap for prescription drugs has been added. The dispensing fee cap will align with the BC PharmaCare Program. Currently, the PharmaCare dispensing fee cap is \$10.00 per prescription.
Effective Date	April 1, 2013.
Contribution Rate	As a result of the EHC plan change your EHC rates have been reduced effective April 1, 2013. These rate changes are as follows: Single: \$37.77 Couple/Family: \$90.64 Invoice adjustments will be reflected on a future PBC invoice.
Employee Communication	Attached to this Guideline is a notice for employees that describes the dispensing fee cap change. We encourage you to distribute this notice to employees covered under the class codes noted on page 1. At a later date, revised benefit booklets will be produced that will include this new benefit provision.

Change in Extended Health Plan Provisions Effective April 1, 2013

Under the provisions of the 2012 - 2014 Health Services and Support Community Subsector Collective Agreement (Community Agreement) a change to your Extended Health Care plan has been made.

Dispensing Fee Cap

A Dispensing Fee Cap for prescription drugs has been added. This means that the reimbursement of dispensing fees for eligible drugs and medications that are dispensed by a pharmacy will be limited to the allowable amount under the BC PharmaCare program. Currently, the PharmaCare Dispensing Fee Cap is \$10.00 per prescription.
